## Compliance Guide

Liberty HealthShare® is the Program name of Gospel Light Mennonite Church Medical Aid Plan, Inc., which is the non-profit ministry that facilitates voluntary contributions for the sharing of qualifying healthcare costs between members. The Program is based on shared ethical and religious beliefs, a religious tradition of mutual aid, neighborly assistance, and financial sharing.

Healthcare Sharing Ministries such as Liberty HealthShare are required to be in compliance with various standards specified by the Internal Revenue Code and state law.

As an Ambassador, it is your obligation to understand these regulations and remain in compliance with them.

Additionally, you are expected to follow Liberty HealthShare's branding guidelines as they apply to any marketing or communications materials you utilize, including but not limited to social media posts, advertising, printed hand-outs, websites, and presentations to potential members.

## Liberty HealthShare's Shared Christian Beliefs
